



MINUTES

MEETING OF THE SUB-COMMITTEE OF NATIONAL COUNCIL FOR VOCATIONAL TRAINING (NCVT) DEALING WITH AFFILIATION SCHEDULED FOR 25th August, 2014 at 11.00 A.M. IN MINI COMMITTEE ROOM OF MINISTRY OF LABOUR & EMPLOYMENT, SHRAM SHAKTI BHAWAN, NEW DELHI.

Meeting of the Sub-Committee of NCVT dealing with affiliation was held on 25th August, 2014 at 11.00 A.M. under the chairmanship of Shri Alok Kumar, Director General/Joint Secretary. List of members present in the meeting is at Annex 'A'.

At the outset, Director General, welcomed the members & reviewed status of reports received from QCI, report processed & pending at DGE&T HQ and reports under clarification which is as follows:



Item No. 1: Confirmation of minutes of the meeting held on 31.07.2014.

DG/JS reviewed the progress on minutes of the last meeting held on 31.7.2014 & informed that he has spoken to secretary (L), Rajasthan, regarding proposal for rationalization of numbers of units for the trade Electrician and in this regard, a reminder letter has to be issued. Sh. Sohan Lal Gupta, representative of BMS raised that a large number of cases of affiliation are being dealt in short time span and there are possibilities that some institutes (Polytechnics) may be doing duplication of institutes i.e. Polytechnics may be taking affiliation of ITIs. DG/JS & DDG (T) advised him to highlight the case before Sub-Committee, if any known to him for taking strict action. Accordingly, QCI was also advised to take appropriate measures during inspection especially to restrict duplication of institutes. It was advised that important information /notices related to ITIs ought to be published on web-portal for general awareness to discourage involvement of agents/consultants in the process of affiliation. It was also clarified that heavy rush was because of abolition of February Session & non holding of meeting of Sub-Committee for nearly 07 months (Oct13-April 14). Sub-Committee confirmed the minutes of the meeting.



Item No. 2: Matter of running of 3rd shift

Members deliberated on the issue with all its pros & cons in implementation of 3rd shifts. Letter submitted by the Director of Chhattisgarh dated 15.07.2014 was considered and it was concluded that it would be appropriate to restrict 3rd shifts in the State(s) unwilling to implement due to State Govt. policies.

It was also decided to communicate withdrawal of 3rd shifts granted affiliation in respect of Kabirdham Private ITI, Dist. Kabirdham, Pin-491995 & not to grant affiliations of 3rd shifts for the proposals being put up to the Sub-Committee in respect of State of Chhattisgarh.

During discussion, DG/JS asked the progress of letter sent to State of Bihar to review implementation of 3rd shifts similar to other States. Sh. Sanjay Kumar, ADT, DET Bihar apprised that till moment matter has not come to his notice and requested that a copy of the letter written to State Director be made available to him, for taking up the matter with State Govt.

Item No 03& 04. Observations in reports & clearance of reports

Sh. A.K. Jain, Principal Adviser, QCI apprised that huge numbers of applications (nearly 700) were received on last date i.e. 31.05.2014 & a number of inspections are in pipeline and reports are expected by next 5-6 days. He requested to conduct next meeting on 08.09.2014 to cover the pending reports. DDG (T) also highlighted that he is in receipt of number of representation for extension of date of admission because of floods in Bihar, Uttrakhand, Uttar Pradesh & epidemics in other State etc. After long deliberation considering all situations, it was decided:

- ✓ To keep last date of application for grant of affiliation for next year on **31st March, 2015** with wide publicity on newspapers, web-portals etc immediately & to block receipt of applications after **31st March, 2015**.
- ✓ To conduct next meeting on 08.09.2014 & accordingly extension of date of admissions upto **15th September, 2014**.
- ✓ Reports under observations may be put up in the ensuing meeting of Sub-Committee of NCVT dealing with affiliation.

Item No 5. Implementation of Judgement dated 22.07.2014 of the Hon'ble Court of Judicature at Bombay in WP 2804 of 2014 filed by Dnyandeep Education Society, AbhaySankul, Satana Road Malegaon, Distt. Nasik on behalf of its institute Swami Private Industrial Training, Satana Naka, Kath Wala Building, Malegoan, Distt. Nasik, Maharashtra-423203.

In compliance with the decision of Hon'ble High Court, the Sub- Committee discussed the matter of permission of students to appear in exam in respect of Fitter Trade of the above mentioned institute.

It was concluded to comply with the order of Hon'ble High Court, permission is granted for 42 students to appear in next forthcoming supplementary examination of 2014.

Item No 6. Consideration of recommendations in respect of **458** inspection reports/Clarification received from States/UTs and QCI.



Additional Item:

- a. Sh. A. K. Jain also apprised that 20 cases of re-affiliation (Orissa & Uttar Pradesh) are received. In support, DG/JS highlighted that clear cut norms are being uploaded to facilitate management of the institutes to apply expeditiously & stick to the schedule given by DGE&T.
- b. DDG (T) raised that Government of Andhra Pradesh had issued an order long back with the direction that availability of 90% infrastructure is sufficient for affiliation. In this regard, DG/JS explained that infrastructure other than space would be required as 100% with slight relaxations as specified in the order for re-affiliation, but if affiliation was given with 90% of space, it will be accepted during re-affiliation.

The meeting ended with a vote of thanks to the chair.
