



MINUTES

MEETING OF THE SUB-COMMITTEE OF NATIONAL COUNCIL FOR VOCATIONAL TRAINING (NCVT) DEALING WITH AFFILIATION HELD ON 8.9.2014 at 3.30 P.M. IN COMMITTEE ROOM OF MINISTRY OF LABOUR & EMPLOYMENT, SHRAM SHAKTI BHAWAN, NEW DELHI.

Meeting of the Sub-Committee of NCVT dealing with affiliation was held on 8.9.2014 at 3.30 P.M. under the chairmanship of Shri Alok Kumar, Director General/Joint Secretary. List of members present in the meeting is at Annex 'A'.


Item No.1:- Confirmation of minutes of the meeting held on 25.8.2014.

DG/JS reviewed the progress on minutes of the last meeting held on 25.8.2014. He inquired from the representative of Rajasthan about progress of the letter written to the Secretary (L), Rajasthan regarding rationalization of nos of units for particular trade(s). Shri R.K. Khandelwal, Dy. Director, DTE Rajasthan apprised that proposal of rationalization of nos of units for trade Electrician was under consideration.

Issue of inconvenience(s) being faced by some of the institutes due to non-clarity of instructions to the assessors as well as institutes came up for discussions. QCI was advised to make the system fool proof, transparent and user friendly. In addition DG/JS suggested to clearly separate Non Conformities (NCs), suggestions and 'Opportunity for improvement' (OFI) for clarity. Reasons for NCs should be very clear and intimation of re-visits should be conveyed by e-mail to the institutes at the earliest.

Item No.2:- Cases for Affiliation/De-affiliation.

a) While going through the proposals for the cases kept under clarification, it was decided that QCI will submit clarifications immediately and decisions will be conveyed within 3 days. Brief of cases kept under clarification in the list of proposals for grant of affiliation is as follows:
